**CERTIFICATE OF AMENDMENT

The total number of outstanding shares of the Corporation is One Hundred Ninety Thousand and Eight-Five (190,085). The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.
