## CORRECTED RELEASE OF SECURITY INTEREST

This Corrected Release of Security Interest ("Release") is effective as of June 27, 2012 (the "Effective Date"), and made by DFA PVA II PARTNERS, LLC, a Delaware limited liability company ("Lender"), in favor of AOS GROUP, LP, a California limited partnership ("Borrower").

### Recitals

WHEREAS, Borrower granted to Lender a security interest in certain Collateral (as defined in the Security Agreement (as defined below)), including without limitation the following trademark registrations:

under a Security Agreement, dated April 2, 2012 ("Security Agreement"), which was recorded on April 5, 2012 with the U.S. Patent and Trademark Office at Reel/Frame 4751/0774, with Borrower at such time having an address of 2183 Fairview Road, Suite 222, Costa Mesa, CA 92627 and Lender at such time having an address of 712 Fifth Avenue, 14<sup>th</sup> Floor, New York, NY, 10019.

WHEREAS, as of June 27, 2012, Borrower had no outstanding obligations to Lender under the terms of the Security Agreement, and Lender had released its security interest in the Collateral.

### Agreement

NOW THEREFORE, Lender acknowledges and agrees that as of June 27, 2012, it terminated and released its security interest in the Collateral and reconveyed to Borrower, without warranty or recourse, all interests of Lender in the Collateral.
