TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Agreement"), is entered into and effective as of the 27th day of August, 2021, by and between AMERICAN VINTAGE HOME HEATING AND AIR CONDITIONING, INC., an Illinois corporation (the "Assignor"), and AMERICAN VINTAGE HOLDINGS, LLC, a Delaware limited liability company ("Assignee").

Assignor has assigned, transferred and conveyed and does hereby assign, transfer and convey unto Assignee, and its successors, assigns and legal representatives, all right, title and interest in and to the Trademarks together with all common law rights and all that part of the goodwill of the business connected with the use of and symbolized thereby, and all claims for damages by reason of past infringement with the right to sue for and collect damages.

Assignor agrees that, when requested, it will sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining the Trademarks in all countries and for vesting title thereto in Assignee, its successors, assigns and legal representatives or nominees.

Assignor covenants to Assignee, its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance by Assignor.




