TRADEMARK AND COPYRIGHT ASSIGNMENT AGREEMENT

- 2. Copyright Assignment.** As of the Effective Date, Big Fish assigns and transfers to 3MG all of Big Fish’s right, title and interest in the copyrights in the Lifeline Games, together with the following U.S. copyright registrations (“**Copyrights**”):
