**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of September 1, 2021 (this "Release"), is made by ANTARES CAPITAL LP, as collateral agent (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") for the Secured Parties in favor of VIGILLO LLC, an Oregon limited liability company (the "Grantor"). Capitalized terms used but not defined herein having the meanings assigned to them in the Guaranty and Security Agreement.

**WITNESSETH**

WHEREAS, Grantor and Collateral Agent are parties to that certain Guaranty and Security Agreement dated as of April 29, 2016 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Guaranty and Security Agreement");

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantor executed the Trademark Security Agreement, dated as of March 20, 2017 (the "Security Agreement") and recorded with the U.S. Patent and Trademark Office on March 21, 2017 at Reel/Frame No. 6013/0977, pursuant to which the Grantor pledged, granted and collaterally assigned to the Collateral Agent for the ratable benefit of the Secured Parties, a security interest in all right, title and interest in the Trademark Collateral (as defined in the Security Agreement).

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral under the Guaranty and Security Agreement and the Security Agreement.
