**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), dated as of August 4, 2021, is made by Antares Capital LP, in its capacity as administrative agent and collateral agent (the “Administrative Agent”), in favor of Court Innovations Incorporated, a Delaware corporation, Bill2Pay, LLC, a Florida limited liability company, Value Payment Systems, LLC, a Tennessee limited liability company, Software Consulting Associates Inc., a New York corporation, Qscend Technologies, Inc., a Delaware corporation, GCS Software, Inc., a Wisconsin corporation, Momix Solutions, Inc., a Texas corporation, Assessment Technologies of Wisconsin, LLC, a Wisconsin limited liability company, Sturgis Web Services Corporation, a South Carolina corporation, Patriot Properties, Inc., a Massachusetts corporation, Pioneer Technology Group, LLC, a Florida limited liability company, and NewVision Systems Corporation, a Delaware corporation (collectively, the “Grantors”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of July 9, 2019 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Grantors and the other parties party thereto in favor of the Administrative Agent, and those certain agreements described on Annex I attached hereto (the “IP Security Agreements”), the Grantors granted a security interest in certain collateral in favor of the Administrative Agent, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Administrative Agent now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. Definitions. The term “IP Collateral”, as used herein, shall mean all of the Grantors’ right, title or interest in, or to any and all of the trademarks, patents and copyrights listed on Annex II attached hereto. Capitalized terms not defined herein have the meanings set forth in the Security Agreement or IP Security Agreements, as applicable.

2. Release of Security Interest. The Administrative Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral, the IP Security Agreements and any and all right, title and interest of the Administrative Agent in, to and under the IP Collateral shall hereby be terminated, cancelled, released, relinquished and discharged. The Administrative Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Administrative Agent’s security interest in the IP Collateral.

3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a manually signed counterpart of this Release. Electronic signatures will have the same force and effect as manual signatures.

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
