TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of September 1, 2021, by BANKUNITED, N.A., with an office at 14817 Oak Lane, Miami Lakes, Florida 33016 ("Bank") in favor of VAYNERSTUDIOS, LLC, a Delaware limited liability company ("Company").

WHEREAS, pursuant to the terms of that certain GRANT OF SECURITY INTEREST (TRADEMARKS) ("Trademark Agreement"), dated as of September 20, 2018 by the Company in favor of the Bank and recorded with the United States Patent and Trademark Office on September 21, 2018 at Reel/Frame 6442/0470, the Company granted to the Bank a security interest and a lien on, and collaterally assigned to the Bank the intellectual property identified on Schedule A attached hereto and associated goodwill (the "Trademark"); and


WHEREAS, the Bank has agreed to terminate and release its security interest and all of its right, title and interest in the Trademark as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates and releases its security interest in and lien on the Company's Trademark, and the Bank hereby assigns and transfers to the Company, without recourse, all of the Bank's right, title and interest in and to the Trademark and related goodwill, effective as of the date set forth above.

Bank hereby authorizes Company or Company's agent or designees to record this Termination and Release of Trademark Security Agreement with the United States Patent and Trademark Office.
