RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 7, 2021 (this “Release”), is made by **CRYSTAL FINANCIAL LLC (D/B/A SLR CREDIT SOLUTIONS)**, a Delaware limited liability company acting in its capacity as administrative agent (in such capacity, the “Grantee”) under that certain Grant of Security Interest in United States Trademarks, dated as of November 4, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Agreement”), by and among **REBECCA TAYLOR, INC.**, a New York corporation and **PARKER LIFESTYLE, LLC**, a Delaware limited liability company (each a “Grantor” and collectively, the “Grantors”) and the Grantee.

WHEREAS, pursuant to the Trademark Agreement which was recorded in the records of the United States Patent and Trademark Office on November 4, 2019 at reel 6786, frame 0977, the Grantors granted to the Grantee a security interest in all of such Grantor’s right, title and interest in, to and under its owned or thereafter acquired United States trademarks, trademark registrations and trademark applications including those set forth on the attached Schedule A (the “Trademark Collateral”);

WHEREAS, pursuant to that certain Payoff Letter, dated as of September 3, 2021 by and between the Grantors, the other signatories party thereto and the Grantee, the Grantors have requested and the Grantee has agreed to (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Trademark Agreement and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Agreement in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Grantee in the Trademark Collateral. The Grantee agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Grantee’s security interests in the Trademark Collateral.


