Assignor does hereby sell, assign, transfer and set over to Assignee, Assignor's entire right, title and interest in and to the Marks, together with the goodwill of the business symbolized by and associated with the Marks, and together with any common law rights, pending applications or issued registrations associated with the Marks, for the United States and for all foreign countries, including any renewals or extensions thereof that are or may be secured under the laws of the United States or foreign countries now or hereafter in effect, for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; together with all income, royalties or payments due or payable as of the effective date of this Assignment or thereafter, including all claims for damages by reason of past, present or future infringement or other unauthorized use, with the right to sue for, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

2. Assignor hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into, nor any act performed, which would conflict with this Assignment.


