**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of September 10, 2021 (“Release”), is made by Churchill Agency Services LLC, as Administrative Agent (“Administrative Agent”) in favor of Arcadia Consumer Healthcare Inc., a Delaware corporation, Kramer Laboratories, Inc., a Florida corporation, Kramer Consumer Healthcare, Inc., a Delaware corporation, and Naturelo Premium Supplements LLC, a Delaware limited liability company (each a “Grantor”, and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of June 22, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantors, Administrative Agent, and others party thereto, and the Trademark Security Agreement dated as of November 4, 2020 (“Trademark Security Agreement”) by and among the Grantors and Administrative Agent, each Grantor granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in and continuing Lien on, all of each Grantor’s right, title and interest in all Trademarks of each Grantor, including without limitation, those Trademarks listed on Schedule A attached hereto; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on November 5, 2020 at Reel 7097 Frame 0233.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in and continuing Lien on, all of each Grantor’s right, title and interest in all Trademarks of each Grantor, including without limitation, those Trademarks listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
