## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of September 20, 2021, by **GOLDMAN SACHS SPECIALTY LENDING GROUP, L.P.**, in its capacity as collateral agent under the security agreements referred to below (“**Collateral Agent**”), in favor of **TERMOPAC INDUSTRIAL, S.A.**, a corporation (*sociedad anónima*) organized under the laws of the Dominican Republic (“**Grantor**”).

**WHEREAS**, reference is hereby made to (a) that certain Pledge and Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 29, 2016, executed by Grantor in favor of Collateral Agent, and (b) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 29, 2016, executed by Grantor in favor of Collateral Agent, and recorded in the records of the United States Patent and Trademark Office on January 4, 2017 at Reel/Frame 5957/0598; and

**WHEREAS**, pursuant to the above-referenced security agreements, Grantor granted to Collateral Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A hereto (collectively, the “**Trademark Collateral**”).

**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby (i) terminates and releases all security interests and continuing liens granted by Grantor in favor of Collateral Agent in the Trademark Collateral; (ii) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Collateral Agent’s security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
