Riskalyze, Inc., a Delaware corporation ("Sub"), does hereby certify to the following facts relating to the merger (the "Merger") of Riskalyze, Inc., a California corporation ("Riskalyze California"), with and into Sub, with Sub remaining as the surviving corporation of the Merger (the "Surviving Corporation"):

- FIRST:** Riskalyze California is incorporated pursuant to the Corporations Code of the State of California and Sub is incorporated pursuant to the General Corporation Law of the State of Delaware ("DGCL"). Riskalyze California and Sub are the constituent corporations in the Merger.
- SECOND:** An Agreement and Plan of Merger and Reincorporation dated as of December 31, 2018, by and between Sub and Riskalyze California has been approved, adopted, certified, executed and acknowledged by Work Truck California and Sub in accordance with the provisions of Section 252 of the DGCL.
- THIRD:** The surviving corporation of the Merger shall be Riskalyze, Inc., a Delaware corporation.
- FOURTH:** Upon the effectiveness of the Merger, the certificate of incorporation of Sub shall continue to be the certificate of incorporation of the Surviving Corporation.
- FIFTH:** The executed Agreement and Plan of Merger and Reincorporation is on file at the principal place of business of Sub, the Surviving Corporation, at 373 Elm Avenue, Auburn, CA 95603.
- SIXTH:** A copy of the executed Agreement and Plan of Merger and Reincorporation will be furnished by Sub, the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation of the Merger.
- SEVENTH:** The authorized stock and par value of the Riskalyze California consists 8,350,000 shares of Common Stock, \$0.001 par value per share and (ii) 2,334,273 shares of Preferred Stock, \$0.001 par value per share.
