NUNC PRO TRADEMARK ASSIGNMENT



NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby acknowledges and confirms that pursuant to that certain Pre-Closing Contribution Agreement, ASSIGNOR did transfer, and assign to said ASSIGNEE the entire right, title, and interest in and to the said Trademarks and Trademark Rights, including the associated goodwill, the same to be held and enjoyed by Assignee as fully and entirely as the same would have been held by ASSIGNOR had this assignment not been made.




