**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “Release”), dated as of September 21, 2021, is made by KIAN MEZZANINE PARTNERS II, L.P., a Delaware limited partnership, as the administrative agent and collateral agent for the Lenders (“Agent”), under that certain Second Amended and Restated Trademark Security Agreement, dated as of March 29, 2019, by THE RETROFIT SOURCE, LLC, a Delaware limited liability company (“Grantor”), in favor of Agent (as amended, supplemented or modified and in effect from time to time, collectively, the “IP Security Agreement”). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

**WHEREAS**, pursuant to the IP Security Agreement, Grantor granted a security interest to Agent (for benefit of the Lenders) in and to a lien on all of such Grantor’s right, title and interest, whether now existing or hereafter arising or acquired, in and to its Collateral, including, but not limited, to the Trademarks set forth on Exhibit A thereto; and

**WHEREAS**, executed copies of the IP Security Agreement were recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office on April 1, 2019 at Reel 6605, Frame 0208; and

**WHEREAS**, Agent has agreed to terminate, release and discharge its security interest in all of such Collateral, including, without limitation, the Collateral identified on Exhibit A attached hereto, being the same Collateral set forth on Exhibit A to the IP Security Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, irrevocably and unconditionally (a) terminate and cancel the liens and security interest created under the IP Security Agreement in the Collateral, (b) release its security interest in the Collateral, and (c) discharge any and all rights, title and interest it has in the security interest granted to Agent in the Collateral, in each case, the Collateral shall include, without limitation, the Trademarks set forth on Exhibit A.

Agent agrees to take all further actions, and provide to the Grantors and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release.


