**TERMINATION OF SECURITY INTEREST AND RELEASE OF

WHEREAS, the Grantors granted the Releasing Party a security interest in the Trademarks (as defined in the Security Agreement), including, without limitation, the trademarks and/or trademark applications and service marks listed on Schedule B pursuant to the Security Agreement, which was recorded in the United States Patent and Trademark Office on April 18, 2012 at Reel/Frame 4759/0389 (the "Trademarks" and the Trademarks together with the Patents, the "Intellectual Property").


