RELEASE OF INTELLECTUAL PROPERTY COLLATERAL

This RELEASE OF INTELLECTUAL PROPERTY COLLATERAL (this “Release”) is made as of July 26, 2021 by MORGAN STANLEY SENIOR FUNDING, INC., as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties (as defined in the Credit Agreement referred to below), in favor of MCAFEE, LLC (the “Company”) and each of the other persons listed on Exhibit A attached hereto (together with the Company, each a “Grantor” and collectively the “Grantors”). Capitalized terms used but not defined herein have the meanings given to them in the Credit Agreement or the Security Agreement (as defined below), as appropriate.

WHEREAS, the Grantors entered into that certain First Lien Credit Agreement, dated as of September 29, 2017, among the Company, McAfee Finance 2, LLC, each lender from time to time party thereto (collectively, the “Lenders” and, individually, a “Lender”), and MORGAN STANLEY SENIOR FUNDING, INC., as administrative agent and collateral agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”);

WHEREAS, as a condition precedent to the making of Loans by the Lenders from time to time, each Grantor executed and delivered that certain First Lien Pledge and Security Agreement, dated as of September 29, 2017, by and among the Grantors and the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the applicable Grantors executed (i) that certain Trademark Security Agreement, dated as of September 29, 2017 (the “McAfee Trademark Security Agreement”), (ii) that certain Patent Security Agreement, dated as of September 29, 2017 (the “McAfee Patent Security Agreement”), (iii) that certain Trademark Security Agreement, dated as of April 10, 2018 (the “Skyhigh Trademark Security Agreement”) and (v) that certain Patent Security Agreement, dated as of April 10, 2018 (the “Skyhigh Patent Security Agreement”), pursuant to which the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in certain intellectual property of the Grantors;

WHEREAS, (i) the McAfee Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 12, 2018 at Reel 6248, Frame 0831, (ii) the McAfee Patent Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on January 12, 2018 at Reel 045056, Frame 0676 (with a corrective assignment recorded at Reel 054206, Frame 0593), (iii) the Skyhigh Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on July 20, 2018 at Reel 6386, Frame 0632 and (v) the Skyhigh Patent Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on July 20, 2018 at Reel 046416, Frame 0225; and

WHEREAS, in accordance with the provisions of the Credit Agreement, the Security Agreement, the McAfee Patent Security Agreement, the McAfee Trademark Security Agreement, the Skyhigh Trademark Security Agreement and the Skyhigh Patent Security Agreement, the Collateral Agent now desires to terminate and release its security interest in and to the Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent, on behalf of itself and the Secured Parties, hereby (a) terminates the Skyhigh Trademark Security Agreement, (b) terminates

the Skyhigh Patent Security Agreement and (c) terminates, releases and discharges to the Grantors all of the Collateral Agent's and the Secured Parties' security interest in all of the Grantors' right, title and interest in and to, and reassigns to the Grantors any right, title and interest the Collateral Agent or any Secured Party may have in or to, the following (collectively, the "Collateral"):

- (i) the patents and patent applications set forth in Schedule A hereto (the "Patents");
- (ii) the trademark and service mark registrations and applications set forth in Schedule B hereto, together, in each case, with the goodwill symbolized thereby (the "Trademarks");
- (iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing;
- (v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing; and
- (vi) all income, royalties and other payments now or hereafter due and payable with respect to any and all of the foregoing.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer or relevant governmental authority record this Release.

SECTION 3. Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. The words "execution," "signed," "signature," "delivery," and words of like import in or relating to this Release and/or any document to be signed in connection with this Release and the transactions contemplated hereby shall be deemed to include Electronic Signatures (as defined below), deliveries or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be. As used herein, "Electronic Signatures" means any electronic symbol or process attached to, or associated with, any contract or other record and adopted by a person with the intent to sign, authenticate or accept such contract or record.


SECTION 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
