## RELEASE OF SECURITY INTEREST

**THIS RELEASE OF SECURITY INTEREST (“Release”)**, effective as of September 28, 2021 (**“Effective Date”**), is conveyed from **THE BANK OF NOVA SCOTIA, AS ADMINISTRATIVE AGENT**, a Schedule 1 Canadian Bank having a place of business at 40 King Street West, 62<sup>nd</sup> Floor, Toronto, Ontario, Canada M5W 2X6 (**“Secured Party”**) to, and for the benefit of, **BANKCARD USA MERCHANT SERVICES, INC.**, a California company having a place of business at 2625 Townsgate, Suite #100, Thousand Oaks, California 91361 (**“Debtor”**).

### RECITALS

**WHEREAS**, Secured Party and Debtor are parties to that certain General Security Agreement dated May 7, 2021, as amended, modified, supplemented or restated from time to time (**“Security Agreement”**);

**WHEREAS**, pursuant to the Security Agreement, Debtor granted a security interest (**“Security Interest”**) to Secured Party in the intellectual property identified on the attached **Schedule A**, any and all applications therefore, any and all registrations and patents thereof, and any and all goodwill associated therewith (collectively, **“IP”**);

**WHEREAS**, Debtor executed that certain Confirmation of Security Interest in Intellectual Property dated May 7, 2021, confirming the grant of the Security Interest to Secured Party (**“Security Confirmation”**);

**WHEREAS**, the Security Confirmation was recorded in the trademark division of the United States Patent and Trademark Office on June 1, 2021 at Reel 7312 and Frame 0214;

**WHEREAS**, the Security Confirmation was recorded in the patent division of the United States Patent and Trademark Office on June 2, 2021 at Reel 056414 and Frame 0058; and

**WHEREAS**, Secured Party now desires to terminate and release the Security Interest in the IP.

**NOW THEREFORE**, in consideration of the above recitals and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby agrees and states as follows:

**1. Release of Security Interest.** Secured Party hereby terminates, releases and discharges the Security Interest in the IP. Any and all right, title and interest of Secured Party in or to the IP shall hereby cease and become void, revoked and terminated.

**2. Further Assurances.** Secured Party hereby agrees, at the sole cost and expense of Debtor, to execute and deliver any further documents to the extent necessary to effect the release of the Security Interest.
