**DECLARATION OF MICHAEL MURPHY**

I, Michael Murphy, pursuant to 28 U.S.C. § 1746, declare as follows:

1. I am over the age of 18 and competent to testify to the matters stated in this declaration. I make this declaration based on my personal knowledge.

2. I am the owner of U.S. Trademark Reg. No. 5,433,422 for the trademark ILLUMAGLOW 2.0 (“the ‘422 Registration”) and 5,437,444 for the trademark ULTRA-GLOW SUPER STARS (“the ‘444 Registration”). I am submitting this declaration to explain why a purported assignment recorded as of July 7, 2021 in the USPTO’s assignment records at Reel/Frame: 7377/0753 should not be considered against the ‘422 Registration and the ‘444 Registration, both owned by me.

3. Attached hereto as Exhibit A are true and correct copies of screenshots of the USPTO’s TSDR records indicating that I am owner of record for the ‘422 Registration and the ‘444 Registration as of October 5, 2021.

4. On June 14, 2019, an assignment agreement was recorded with the United States Patent & Trademark Office (USPTO) for the ‘422 Registration and the ‘444 Registration, among other trademarks. This agreement assigned all rights and interest from the original applicant Kangaroo Manufacturing, Inc. to Optimistic Investments, LLC and was in the USPTO’s assignment records at Reel/Frame: 6670/0275 (the “Optimistic Investments Assignment”).

5. On June 12, 2020, an assignment agreement (executed June 11, 2020) was recorded with the USPTO for the ‘422 Registration and the ‘444 Registration. This agreement assigned all rights and interest from Optimistic Investments to me, individually, and was recorded with the USPTO in the USPTO’s assignment records at Reel/Frame: 6969/0938 (the “Murphy Assignment”).

6. Attached hereto as Exhibit B are true and correct copies of screenshots of the USPTO's online assignment records for the '422 Registration and the '444 Registration as of October 5, 2021.

7. On July 7, 2021, an assignment agreement was recorded with the United States Patent & Trademark Office (USPTO) for the '422 Registration and the '444 Registration, among other trademarks. This agreement purports to assign all rights and interest from the original applicant Kangaroo Manufacturing, Inc. to Benjamin Joseph Ligeri (the "False Ligeri Assignment"). The False Ligeri Assignment purports to claim it was executed on February 15, 2019, prior to the May 30, 2019 execution date of the "Optimistic Investments Assignment". The False Ligeri Assignment was recorded in the USPTO's assignment records at Reel/Frame: 7377/0753.

8. On information and belief, I believe that the False Ligeri Assignment is false, void and invalid and has no effect on the chain of title for the '422 Registration and the '444 Registration.


9. Further on information and belief, I believe that the False Ligeri Assignment was recorded with a fraudulent intent to cloud the chain of title for the '422 Registration and the '444 Registration.

10. Further on information and belief, I believe that the False Ligeri Assignment was recorded in an improper attempt to change the owner and correspondent of record for the '422 Registration and the '444 Registration with an ultimate goal of misrepresenting ownership to and interfering with my business relationship with Amazon, Inc., a company that operates the online retail website [Amazon.com](https://www.amazon.com).

11. Optimistic Investments, LLC has also asserted that the False Ligeri Assignment is invalid and void. Optimistic Investments, LLC has recorded a declaration of its counsel, Ms. Susan E. Chetlin, detailing its assertion in the USPTO's assignment records at Reel/Frame: 7420/0289 and confirming the assignment of the '422 Registration and the '444 Registration from Optimistic Investments to myself on June 11, 2020 (recorded June 12, 2020). See ¶3 of the declaration of Susan E. Chetlin in the USPTO's assignment records at Reel/Frame: 7420/0289.

I declare under penalty of perjury under the laws of the United States that the foregoing is true and correct.
