**RELEASE OF PATENT AND TRADEMARK SECURITY INTERESTS AND
CONFIRMATORY REASSIGNMENT OF PATENTS AND TRADEMARKS**

This RELEASE OF PATENT AND TRADEMARK SECURITY INTERESTS, dated as of October 12, 2021, is made by the Lender, and releases (x) all of the security interests held by the Lender in each of the patents and patent applications identified on Schedule A (the "Patent Collateral") and the trademark registrations and trademark applications identified on Schedule B, which were granted by the Grantors to the Lender pursuant to the Patent and Trademark Security Agreement, and (y) all of the security interests held by the Lender in each of the trademark registrations and trademark applications identified on Schedule C (together with the trademark registrations and trademark applications identified on Schedule B, the "Trademark Collateral"), which were assigned by JPMorgan to the Lender pursuant to the Trademark Assignment Agreement. The Lender reassigns any and all rights, titles and interest on the Patent Collateral and the Trademark Collateral, including the goodwill business associated with the Trademarks, without any representation, warranty, recourse or undertaking by the Lender to the Grantors.

Nothing herein constitutes a release or satisfaction of any indebtedness owing by the Grantors or their affiliates to the undersigned.
