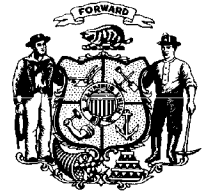



## PLAN OF CONVERSION

1. Before Conversion: Company Name: PRN Health Services, Inc., a business corporation, organized under the laws of Wisconsin. (Ch. 180, Wis. Stats.)
2. After Conversion: Company Name: PRN Health Services LLC, a limited liability company, organized under the laws of Wisconsin. (Ch. 183, Wis. Stats.)
3. The terms and conditions of the conversion:

The board of directors of PRN Health Services, Inc. has adopted a resolution approving the plan of conversion and specifying that PRN Health Services, Inc. shall be converted into a Wisconsin limited liability company known as, PRN Health Services LLC. The Shareholder of PRN Health Services, Inc. has voted to adopt such proposed resolution of the board of directors.
