## ACKNOWLEDGEMENT AND ASSIGNMENT

This Acknowledgement and Assignment (the "Assignment"), entered into on October 3, 2021, is by and among RBH Subsidiary LTT, Inc., formerly known as LT Trust Company ("RBH"); American Trust Company ("American Trust"); and Mid Atlantic Capital Group, Inc. ("Mid Atlantic"). Each of the foregoing is also referred to in this Assignment as a "Party" and collectively as the "Parties."

### RECITALS

WHEREAS, on June 22, 2021, several entities, including LT Trust Company (n/k/a RBH) and American Trust, entered into an Asset Purchase Agreement ("APA") whereby American Trust acquired all right, title and interest in, to and under certain LT Trust Company assets, properties, rights and interests, including the trademark registration identified on Exhibit A hereto (hereinafter "the Trademark");

WHEREAS, RBH joins herein in order to confirm and acknowledge that LT Trust Company sold, assigned and transferred its interest in the Trademark to American Trust via the APA; and

WHEREAS, American Trust now desires to assign and transfer all of its right, title and interest in and to the Trademark to Mid Atlantic.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties hereto agree as follows:

1. **Acknowledgment.** RBH acknowledges, agrees and confirms that LT Trust Company sold, assigned and transferred all of its right, title and interest in and to the Trademark to American Trust via the APA, together with the goodwill of the business associated with and symbolized by the Trademark.
2. **Assignment.** As current owner of the Trademark, American Trust hereby desires to assign and transfer to Mid Atlantic all right, title and interest in and to the Trademark, together with the goodwill of the business associated with and symbolized by the Trademark.
3. **Binding Effect.** This Assignment shall be binding upon and inure to the benefit of the agents, partners, successors, heirs, and assigns of the Parties. This Assignment shall be binding, enforceable, discoverable, and admissible to establish the rights, obligations and duties of the Parties hereunder in any action brought to enforce the Assignment.
4. **Counterparts.** This Assignment may be executed by facsimile transmission, electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, or by a combination of such means. Such electronic transmission shall constitute effective execution and delivery and may be used in lieu of an original for all purposes. A signature transmitted by facsimile or other electronic transmission shall be deemed to be an original signature for all purposes. An electronic signature shall be deemed an original signature for purposes of this Assignment, and having the same legal effect as original or "wet" signatures.
