**ARTICLES OF AMENDMENT

Pursuant to Title 13.1, Chapter 9, Article 11 of the Code of Virginia, the undersigned corporation executes the following Articles of Amendment:

1. The name of the corporation is Sonabank (the "Corporation").
2. The Amended and Restated Articles of Incorporation of the Corporation are hereby amended by deleting Article FIRST thereof in its entirety and replacing it with a new Article FIRST to read as follows.


"FIRST The name of this corporation (the "Corporation") shall be "Primis Bank."
