TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of October 19, 2021 (the "Release Date"), by the Bank of West, a California banking corporation, for itself and as administrative agent (in such capacity, the "Administrative Agent") for the Lender Parties, as defined in the Credit Agreement described below, for the benefit of Northwire, Inc., a Minnesota corporation ("Debtor").

WHEREAS, Debtor had entered into that certain Credit Agreement (together with all amendments, modifications and restatements of such agreement, the "Credit Agreement"), dated as of June 5, 2013 among the Debtor, the several banks and other financial institutions from time to time party thereto as lenders and the Administrative Agent, the Lender Parties had agreed to make advances to and issue letters of credit for the account of Debtor;

WHEREAS, as a condition of extending credit under the Credit Agreement, the Lenders required the execution and delivery by the Debtor of a Security Agreement (together with all amendments, modifications and restatements of such agreement, the "Security Agreement") dated June 5, 2013, pursuant to which the Debtor granted the Administrative Agent a security interest in all of the Debtor's personal property;

WHEREAS, pursuant to said Security Agreement, Debtor executed and delivered to the Administrative Agent a Trademark Security Agreement dated June 5, 2013;

WHEREAS, pursuant to the Trademark Security Agreement, in conjunction with the Security Agreement, the Debtor pledged and granted to the Administrative Agent a lien on and security interest in and to all of its right, title and interest in, to and under all of the following Trademark Collateral of the Debtor, whether then existing or thereafter arising or acquired from time to time (collectively, the "Trademark Collateral"): each trademark, trademark registration, and trademark application listed on Schedule A thereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application;

WHEREAS, the Administrative Agent filed with the United States Patent and Trademark Office (the "USPTO") notices of security interests in the Trademark Collateral pursuant to the Trademark Security Agreement, the Trademark Security Agreement was recorded by the USPTO on June 5, 2013, at Reel 5041, Frame 0464; and

WHEREAS, the Obligations have been paid in full and the Debtor has requested that the Administrative Agent release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent agrees as follows:


1. Release of Security Interest. Effective as of the Release Date, the Administrative Agent hereby, on behalf of itself and as administrative agent, irrevocably and forever terminates, releases and discharges the Trademark Security Agreement, any and all of its continuing security interest in, and all of its right, title and interest in, to and under, the Trademark Collateral granted by the Debtor under the Security Agreement and the Trademark Security Agreement. The Administrative Agent reassigns to Debtor all right, title and interest to all Trademark Collateral referred to in the Trademark Security Agreement.

2. Recordation of Release. The Debtor shall cause this Release to be recorded with the U.S. Patent and Trademark Office for the purpose of recording the release of the Administrative Agent's security interest in the Trademark Collateral.

3. Further Actions. The Administrative Agent further agrees to provide to the Debtor and its successors, assigns or other legal representatives, all such cooperation and assistance (including without limitation to execute any other documents) and take any further action that the Debtor may reasonably request to effect the intent and purpose of this Release; provided, that all such documents are to be prepared by counsel to the Debtor and the cost and expense of such documents and actions shall be borne solely by the Debtor.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release to be executed as an instrument under seal by its duly authorized officer as of the Release Date.
