2. The Company's Articles of Organization were originally filed on June 2, 2017.
3. The text of each amendment adopted by the Company (the "*Amendment*") is set out in full as follows:


Article 1 of the Company's Articles of Organization is hereby amended and restated in its entirety to read as follows:

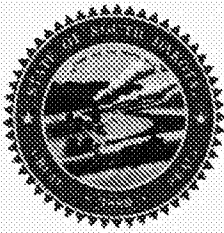
