RELEASE OF TRADEMARK SECURITY AGREEMENT (US)

This **RELEASE OF TRADEMARK SECURITY AGREEMENT**, dated as of October 21, 2021 (this "Release"), is made by NATIONAL HOCKEY LEAGUE, on behalf of itself and each other NHL Priority Party (the "NHL") in favor of HURRICANES HOCKEY LIMITED PARTNERSHIP, a Delaware limited partnership located at 1400 Edwards Mill Road, Raleigh, NC 27607 (the "Grantor").

WHEREAS, the Grantor is party to a Security Agreement, dated as of March 12, 2014 (the "Security Agreement"), by and among the Grantors party thereto and the NHL pursuant to which the Grantor granted a security interest to the NHL on behalf of itself and each other NHL Priority Party in the Trademark Collateral.

WHEREAS, under the terms of the Security Agreement, the Grantor executed the Trademark Security Agreement, dated March 12, 2014, between the Grantor and the NHL and recorded with the United States Patent and Trademark Office at Reel 005239, Frame 0293.

WHEREAS, the Grantor has requested that the NHL enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest the NHL may have in the Trademark Collateral pursuant to the Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the NHL hereby agrees with the Grantor as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Release of Security. The NHL, on behalf of itself and each other NHL Priority Party, hereby releases to the Grantor, the security interest granted to the NHL pursuant to the Security Agreement in and to the Trademark Collateral, including the trademark registrations and applications listed in Schedule A attached hereto.

SECTION 3. Recordation. The NHL authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

SECTION 4. Governing Law. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.

SECTION 5. Counterparts. This Agreement may be executed in any number of counterparts and by the different parties hereto on separate counterparts, each of which shall be an original, but all of which together shall constitute one instrument.


