TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of October 22, 2021, by WHITEHORSE CAPITAL MANAGEMENT, LLC, in its capacity as Collateral Agent (in such capacity, "Collateral Agent"), in favor of UNIVERSAL BACKGROUND SCREENING, INC., a Delaware corporation ("Universal Background Screening") and PEOPLEFACTS, LLC, a Delaware limited liability company ("PeopleFacts") (collectively, the "Grantors"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement or Trademark Security Agreements (both as defined below).

WITNESSETH:

WHEREAS, pursuant to that certain Credit Agreement, dated as of January 31, 2019 (as the same may be amended, restated, supplemented or otherwise modified from time to time), by and among Pluto Acquisition Topco, LLC (the "Borrower"), Pluto Acquisition Holdco, LLC, Pluto Acquisition OpCo, LLC, the other persons party thereto from time to time as Guarantors, the Collateral Agent and the financial institutions party thereto from time to time as Lenders, the Lenders made certain financial accommodations available to the Borrower;

WHEREAS, as a condition precedent to the making of such financial accommodations, the Grantors were required to execute and deliver to the Collateral Agent that certain Security Agreement, dated as of January 31, 2019 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors entered into those certain Trademark Security Agreements (the "Trademark Security Agreements") pursuant to which the Grantors granted, mortgaged, pledged and hypothecated to the Collateral Agent for the benefit of the Lenders a continuing security interest in all of the Grantors' right, title and interest in and to the Grantors' Trademarks listed on Schedule I attached hereto (collectively, the "Trademark Collateral");

WHEREAS, the Trademark Security Agreement against Universal Background Screening was recorded with the United States Patent and Trademark Office (the "USPTO") on January 31, 2019 at Reel 6546, Frame 0710;

WHEREAS, the Trademark Security Agreement against PeopleFacts was recorded with the USPTO on January 31, 2019 at Reel 6546, Frame 0702;

WHEREAS, Collateral Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral; and

WHEREAS, the Grantors have satisfied and fulfilled all of their obligations to release the Collateral Agent's security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Collateral Agent hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges its security interest in all of the Grantors' entire right, title and interest in, to and under the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

2. Collateral Agent hereby grants and conveys to the Grantors, without any representation, recourse or undertaking by Collateral Agent, any and all of Collateral Agent's right, title and interest in and to the Trademark Collateral.

3. Collateral Agent hereby authorizes and requests that this Trademark Release be recorded at the USPTO, or any other applicable location. Collateral Agent shall take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, and at Grantors' cost and expense, to more fully and effectively effectuate the purposes of this Trademark Release.


