**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Agreement") dated as of November 1, 2021, from Bank of America, N.A., in its capacity as administrative agent (the "Administrative Agent"), in favor of ITN Holdings, LLC (f/k/a ITN Networks, LLC), a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, in connection with the Trademark Security Agreement, dated as of March 28, 2016 (the "Trademark Security Agreement"), the Administrative Agent was granted a security interest and continuing lien in the Grantor's trademarks and trademark applications listed in the Trademark Security Agreement;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Assignment Division of the United States Patent and Trademark Office (the "USPTO") on March 31, 2016 at Reel 5761, Frame 0985;

WHEREAS, the Administrative Agent now wishes to release its liens on, and security interests in, the trademark set forth on Schedule A (the "Released Trademark") in the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Agreement, the Administrative Agent hereby states as follows:

1. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges all of its security interest in the Released Trademark, including any associated goodwill or common law rights, and reassigns any and all right, title and interest that it may have in or to the Released Trademark.
2. Recordation. The Grantor and/or its authorized agent is authorized to record this Agreement with the USPTO.
3. Governing Law. This Agreement and the rights and obligations of the parties under this Agreement shall be construed in accordance with and governed by the laws of the State of New York.
4. Further Assurances. The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at Grantor's cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.
