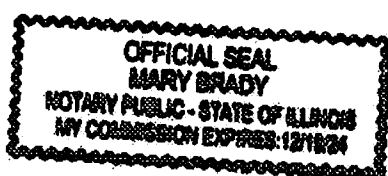

I, JoAnn Gilley, under the penalty of perjury, state as follows:

1. I am over twenty-one years of age and am competent to testify to the matters set forth herein.

2. I currently serve as, and as of 10/25/17 served as, Chief Executive Officer of Overture Promotions Inc. Accordingly, I have first-hand knowledge of the facts and statements made herein.

3. Effective as of February 11, 2021, prior registrant Overture, LLC assigned to Overture Promotions Inc. the BLUE SODA PROMO trademark along with its Registration No. 3984304. Overture Promotions Inc. is the current owner of the BLUE SODA PROMO trademark and Registration No. 3984304.

4. The assignment was memorialized with an Assignment of Trademark document recorded in the United States Patent and Trademark Office (“USPTO”) on March 3, 2021 at Reel/Frame 7209/0031 (the “Assignment Document”).

5. The Assignment Document and the Recordation Form Cover Sheet accompanying the Assignment Document when it was recorded in the USPTO included a typographical error for the name of Overture Promotions Inc., the receiving party (assignee).


6. Specifically, Overture Promotions Inc. was identified as “Overture Promotions, Inc.” instead of “Overture Promotions Inc.” In other words, a comma was added after the word “Promotions”. This error occurred without deceptive intent.

7. The correct entity name for Overture Promotions Inc. is, and was at the time of the assignment and recordation of the assignment, “Overture Promotions Inc.” (without a comma).

8. This Affidavit is accompanied by a new Recordation Form Cover Sheet and a copy of the Assignment with the corrections thereto initialed by me.

9. To the best of my knowledge, information, and belief, formed after an inquiry reasonable under the circumstances, the allegations and other factual contentions made above have evidentiary support.

10.
