**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of October 29 , 2021 by Venture Lending & Leasing VII, LLC (as assignee of Venture Lending & Leasing VII, Inc.) (the "*Secured Party*"), in favor of FieldAware US, Inc. (the "*Grantor*").

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement, dated as of May 11, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting and pledging to the Secured Party a security interest in certain Trademarks, Patents and Copyrights (in each case as defined in the Agreement), including, without limitation, all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, and all rights corresponding thereto through the world, which was recorded with the United States Patent and Trademark Office ("**USPTO**") on May 15, 2015, at Reel 005517, Frame 0891;

WHEREAS, Grantor has requested that Secured Party hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks, Patents and Copyrights as herein provided; and

WHEREAS, Grantor has requested that the Secured Party provide a document suitable for recording with the USPTO to evidence the release of the Secured Party's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby:


1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests in Grantor's right, title and interest in, to and under the Patents, Trademarks and Copyrights, and all goodwill associated therewith, including, without limitation, the Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF CALIFORNIA.
