AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT is entered into as of October 29, 2021 (this “Agreement”), by SHELTERLOGIC CORP., a Delaware corporation (“ShelterLogic Corp.”), SOJAG INC., a Canadian corporation (“Sojag”), and ARROW SHED, LLC, a Delaware limited liability company (“Arrow Shed” and, together with ShelterLogic Corp. and Sojag, each a “Grantor” and collectively, the “Grantors”), in favor of CERBERUS BUSINESS FINANCE AGENCY, LLC (“Cerberus”), as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties.

Reference is made to (a) that certain Amended and Restated U.S. Pledge and Security Agreement, dated as of October 29, 2021 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”), among the Borrower, the Guarantors party thereto and the Collateral Agent and (b) that certain Notice of Security Interest – Trademarks, dated as of June 22, 2018 (as amended, restated, supplemented or otherwise modified from time to time prior to the date hereof, the “Existing Trademark Security Agreement”), executed by ShelterLogic Corp., Arrow Shed and Rio Brands, LLC, a Delaware limited liability company, as assignors, in favor of Cerberus, as assignee, and recorded with the United States Patent and Trademark Office on June 25, 2018 at Reel/Frame 6363/0375. The Lenders have extended credit to the Borrower subject to the terms and conditions set forth in that Financing Agreement, dated as of June 22, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Financing Agreement”), by and among ShelterLogic Group Holdings, Inc., a Delaware corporation (“Parent”), ShelterLogic Group, Inc., a Delaware corporation (the “Borrower”), each Subsidiary of the Parent from time to time party thereto as a “Guarantor” (together with the Parent, each a “Guarantor” and collectively, the “Guarantors”), the lenders from time to time party hereto (each a “Lender” and collectively, the “Lenders”), the Collateral Agent, and Cerberus Business Finance Agency, LLC, as administrative agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, if any the “Administrative Agent” and, together with the Collateral Agent, each an “Agent” and collectively, the “Agents”). Consistent with the requirements set forth in Section 7.01(b) of the Financing Agreement and Section 6(i) of the Security Agreement, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meaning specified in the Security Agreement.

SECTION 2. Grant of Security Interest. As collateral security for the payment, performance and observance of all of the Secured Obligations, each Grantor hereby pledges and assigns to the Collateral Agent (and its agents and designees), and grants to the Collateral Agent (and its agents and designees), for the benefit of the Secured Parties, a continuing security interest in, the following of such Grantor, wherever located and whether now or hereafter existing and whether now owned or hereafter acquired (collectively, the “Trademark Collateral”):

A. (i) all Trademarks, including the Trademark registrations and registration applications in the United States Patent and Trademark Office listed on Schedule I hereto, (ii) all extensions and renewals thereof, (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (iv) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims and payments for past, present and future infringements or dilutions thereof; (v) all rights to sue for past, present, and future infringements or dilutions of any of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (vi) all rights corresponding to any of the foregoing, in each case, excluding any Excluded Assets; and

B. all Proceeds of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages and proceeds of suit now or hereafter due and/or payable with respect thereto.

SECTION 3. Security Agreement. The security interests granted to the Collateral Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Collateral Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

SECTION 4. GOVERNING LAW. THIS AGREEMENT SHALL BE GOVERNED BY, CONSTRUED AND INTERPRETED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK, APPLICABLE TO CONTRACTS MADE AND TO BE PERFORMED IN THE STATE OF NEW YORK.

SECTION 5. Counterparts. This Agreement may be executed in one or more counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original, but all such counterparts together shall constitute but one and the same instrument.

SECTION 6. Amendment and Restatement. From and after the date hereof, the Existing Trademark Security Agreement shall be amended and restated in its entirety by this Agreement, and the Existing Trademark Security Agreement shall thereafter be of no further force and effect. This Agreement is not in any way intended to constitute a novation of the obligations and liabilities existing under the Existing Trademark Security Agreement. On and after the date hereof, (i) all references to the Existing Trademark Security Agreement (or to any amendment or any amendment and restatement thereof) in the Loan Documents shall be deemed to refer to this Agreement (as it may be further amended, restated, amended and restated or otherwise modified) and (ii) all references to any section (or subsection) of the Existing Trademark Security Agreement shall be amended to become, mutatis mutandis, references to the corresponding provisions of this Agreement.


