## TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (“**Agreement**”) is made and entered into as of the 1st day of April, 2019 by and between American Megatrends International, LLC, a Delaware limited liability corporation (“**Assignor**”), and Amzetta Technologies, LLC, a Georgia limited liability corporation (“**Assignee**”).

Capitalized terms used but not otherwise defined in this Agreement shall have the meanings given to them in that certain Securities Purchase Agreement, dated as of the 23rd day of December, 2018, by and among AMI US Holdings Inc., a Delaware corporation, AMI HK HoldCo Limited, a Hong Kong limited company, AMI Holdings, Inc., a Georgia corporation, Assignee, and American Megatrends, Inc., a Georgia corporation (the “**Purchase Agreement**”).

### RECITALS

**WHEREAS**, pursuant to the Purchase Agreement, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all trademarks, service marks, trade names, brand names, logos and corporate names, slogans, trade dress and other indicia of source of origin, whether or not registered, including, but not limited to, all common law rights thereto and all goodwill associated therewith, and registrations and applications for registration thereof that constitute Remaining Assets, including, but not limited to, the trademark and/or service mark registrations and/or applications identified on **Schedule 1** attached hereto (collectively, the “**Trademarks**”).

### AGREEMENT

**NOW, THEREFORE**, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

- 1. Assignment.** Assignor hereby sells, assigns, conveys and transfers to Assignee, and Assignee hereby purchases, acquires, accepts and assumes from Assignor, all worldwide right, title and interest in, to and under all Trademarks, including, without limitation, any and all common law rights thereto and the goodwill of the Remaining Business symbolized thereby, together with Assignor’s worldwide right to police, monitor and enforce said Trademarks against any and all past and current infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this Agreement, together with any and all further privileges in the United States and throughout the world to establish use, ownership and/or registration of the Trademarks.
- 2. Authorization.** Assignor hereby authorizes the Commissioner of Patents and Trademarks (and the equivalent authority in foreign trademark offices, as applicable) to record this Agreement and transfer the Trademarks to Assignee as assignee of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment.

**3. Governing Agreement.** This Agreement is executed and delivered pursuant to the Purchase Agreement. In the event of an irreconcilable conflict between the terms and provisions of this Agreement and any term or provision of the Purchase Agreement, the conflicting term or provision of the Purchase Agreement shall govern and control to the extent of such conflict. Nothing contained in this Agreement shall alter, extend, diminish or amplify any of the representations, warranties, covenants or obligations of any Party contained in the Purchase Agreement or the survival thereof.

**4. Amendments.** This Agreement may not be amended or modified except by an instrument in writing signed by Assignor and Assignee.

**5. Further Assurances.** From and after the date hereof but subject to the terms and conditions hereof, Assignor and Assignee shall do all such acts and execute all such further documents and instruments as may be reasonably required to memorialize and make effective the transactions contemplated hereby.

**6. Governing Law.** All matters relating to the interpretation, construction, validity and enforcement of this Agreement shall be governed by and construed in accordance with the domestic laws of the State of Delaware without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction) that would cause the application of laws of any jurisdiction other than the State of Delaware.

**7. Counterparts.** This Agreement may be executed in 2 original, facsimile or electronic counterparts, each of which will be deemed an original, both of which when taken together will constitute one and the same instrument.


