**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) dated as of November 22, 2021, is made by Capital One, National Association, as administrative agent (in such capacity, the “**Administrative Agent**”) in favor of Saol Bermuda Limited, an exempted company limited by shares incorporated under the laws of Bermuda (“**Grantor**”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated August 6, 2019 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), the Grantor executed and delivered a Trademark Security Agreement, dated August 6, 2019, in favor of the Administrative Agent (the “**Trademark Security Agreement**”);

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on August 6, 2019 at Reel/Frame 6713/0379;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor pledged, collaterally assigned, mortgaged, transferred, and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in, to and under (i) all of its Trademarks providing for the grant by or to the Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto; provided, however, that the foregoing shall not include any “intent to use” Trademark applications for which a statement of use has not been filed (but only until such statement is filed); (ii) all renewals and extensions of the foregoing; (iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof (collectively, the “Trademark Collateral”); and

WHEREAS the Grantor has requested that the Administrative Agent now release its security interest in the Trademark Collateral.


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Administrative Agent hereby releases its security interest in the Trademark Collateral, and hereby re-assigns to the Grantor any right, title or interest it may have in or to the Trademark Collateral of the Grantor, without recourse to the Administrative Agent and without representation or warranty of any kind.

The Grantor (and any successor to the Grantor, including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of the Grantor) is hereby authorized to record this Release with the United States Patent and Trademark Office.
