TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 23, 2021 (“Release”), is made by Stellus Capital Investment Corporation, as Administrative Agent (“Secured Party”), in favor of Napa Jet Center, Inc., a California corporation (“Grantor”).

WHEREAS, pursuant to that certain Security Agreement dated as of September 30, 2019 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantor, Secured Party, and other Persons party thereto and the Grant of Trademark Security Interest dated as of September 30, 2019 (“Trademark Grant”) by and among the Grantor and Secured Party, Grantor granted to Secured Party, for the benefit of the Lenders, a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral; and

WHEREAS, the Trademark Grant was recorded at the United States Patent and Trademark Office (“USPTO”) on September 30, 2019 at Reel 6818 Frame 0825.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party, on behalf of the Lenders, and Grantor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Grant.

SECTION 2. Termination and Release. Secured Party, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of Grantor’s right, title, and interest in and to the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Grant; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, Secured Party, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
