RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of December 3, 2021 (this “Release”), is made by BANK OF AMERICA, N.A., whose address is 300 S. 4<sup>th</sup> St., Suite 200, Las Vegas, NV 89101, acting in its capacity as the Collateral Agent (“Collateral Agent”) under that certain Intellectual Property Security Agreement, dated as of October 28, 2019 (as amended, supplemented or modified from time to time, the “Security Agreement”) between SNOQUALMIE ENTERTAINMENT AUTHORITY, an unincorporated instrumentality and political subdivision of the Snoqualmie Indian Tribe, a federally recognized Indian tribe, whose address is 37500 SE North Bend Way, Snoqualmie, WA 98065, and Collateral Agent.

Pursuant to the Security Agreement, Grantor granted to Collateral Agent, for the benefit of the Secured Parties referred to therein, a security interest in and to all of Grantor's right, title and interest in Grantor's Trademarks (as defined in the Security Agreement), including, without limitation, those specific trademark registrations and applications listed on Exhibit A attached hereto (the “Released Trademarks”), and the goodwill of the business associated therewith.

The Security Agreement was recorded on October 28, 2019, at Reel/Frame 6781/0604 in the United States Patent and Trademark Office.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Collateral Agent hereby releases, terminates and discharges its security interest in and to the Trademarks, including the Released Trademarks, and the goodwill associated therewith, without representation or warranty of any kind, express or implied.
