RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (this “**Release**”) is made as of December 8, 2021, by **GOLUB CAPITAL LLC**, a Delaware limited liability company, as administrative agent for the Lenders party to the Loan Agreement referred to below (“**Agent**”) in favor of **SNAPLOGIC, INC.**, a Delaware corporation (“**Grantor**”).

Recitals

WHEREAS, Grantor, the other loan parties from time to time party thereto, certain lenders from time to time party thereto (the “**Lenders**”), and Agent entered into a Loan and Security Agreement on September 30, 2019 (as amended, restated, or otherwise modified from time to time, the “**Loan Agreement**”).

WHEREAS, Grantor granted to Agent a security interest in Grantor’s intellectual property, including without limitation, trademarks described on Exhibit A attached hereto (collectively the “**Intellectual Property**”) under that certain Intellectual Property Security Agreement dated as of September 30, 2019 (as amended, restated, or otherwise modified from time to time, the “**IP Security Agreement**”) and recorded on September 30, 2019, reel/frame 6758/0123, with the U.S. Patent and Trademark Office.

WHEREAS, Grantor has requested, and Agent has agreed to release its security interest in the Intellectual Property and terminate the IP Security Agreement.

Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

1. Agent, on behalf of itself and the Lenders, their successors, legal representatives and assigns, hereby terminates, discharges and releases any and all security interests in the Intellectual Property, terminates the IP Security Agreement, and reassigns to Grantor, without warranty or recourse, any and all right, title and interest of Agent in, to and under the Intellectual Property.

2. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
