**AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION  
OF  
JOHNSON CONTROLS REAL ESTATE SERVICES, INC.**

It is hereby certified that:

1. The name of the corporation is Johnson Controls Real Estate Services, Inc. (the "Company"). The Company was originally formed under the name "USI Real Estate Brokerage Services Inc.", and the date of filing of the original certificate of incorporation of the Company with the Secretary of State of the State of Connecticut was May 20, 1992. The Company was renamed "Johnson Controls Real Estate Services, Inc." by certificate of amendment to the certificate of incorporation filed with the Secretary of State of the State of Connecticut on January 29, 2014.

2. This Amended and Restated Certificate of Incorporation amends, restates and replaces the existing certificate of incorporation of the Company in its entirety as follows:

FIRST: The name of the Company is CBRE GWS Real Estate Services, Inc.

SECOND: The address of the registered office of the Company in the State of Connecticut is One Corporate Center, Floor 11, in the City of Hartford.

THIRD: The Company's registered agent at that address is C T Corporation System.

FOURTH: The purpose of the Company is to engage in any lawful act or activity for which a corporation may be organized under the Connecticut Business Corporation Act or any applicable successor act thereto, as the same may be amended from time to time (the "CBCA").

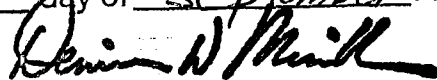
FIFTH: The total number of shares of all classes which the corporation has authority to issue is 1,000,000 shares of common stock, with a par value of \$0.01 per share (the "Common Stock"). The Common Stock shall have unlimited voting rights and shall be entitled to receive the net assets of the Company upon dissolution.

3. The amendments and restatements herein have been duly adopted in the manner prescribed by Sections 33-797 and 33-801 of the CBCA, and this Amended and Restated Certificate of Incorporation is being filed in accordance therewith.
