RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of December 13, 2021 by **BMO HARRIS BANK, N.A.**, in its capacity as administrative agent under the security agreements referred to below (“**Administrative Agent**”), in favor of **CURATION FOODS, INC.**, a Delaware corporation (“**Grantor**”).

WHEREAS, reference is hereby made to (a) that certain Pledge and Security Agreement (as supplemented or otherwise modified from time to time), dated as of December 31, 2020, executed by Grantor in favor of Administrative Agent, and (b) that certain Grant of a Security Interest Trademarks (as supplemented or otherwise modified from time to time), dated as of December 31, 2020, executed by Grantor in favor of Administrative Agent, and recorded in the records of the United States Patent and Trademark Office on January 4, 2021 at Reel/Frame 7154/0134; and


WHEREAS, pursuant to the above-referenced security agreements, Grantor granted to Administrative Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under those trademarks set forth on Schedule A hereto (collectively, the “**Trademark Collateral**”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby (i) terminates and releases all security interests and continuing liens granted by Grantor in favor of Administrative Agent in the Trademark Collateral; (ii) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes Grantor or its designee to make filings with the United States Patent and Trademark Office and to take further actions necessary to evidence the release and termination of Administrative Agent’s security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
