THIS DEED OF ASSIGNMENT is entered into this 29<sup>th</sup> day of August 2018

**BETWEEN**

**OLYMPIA INTERNATIONAL HOLDINGS LIMITED (In Liquidation)** whose registered office is situate at 5/F, Ho Lee Commercial Building, 38-44 D'Aguilar Street, Central, Hong Kong (hereinafter referred to as the "Assignor") of the one part; and

**IP GLOBAL HOLDINGS LIMITED** whose registered office is situate at 160 Wing Ping Tsuen, Santin, Yuen Long, New Territories, Hong Kong (hereinafter referred to as the "Assignee") of the other part.

WHEREAS the Assignor is the registered proprietor of the trademarks, particulars whereof are set out in Schedule A of this Assignment (hereinafter referred to as "the Trademarks")

AND WHEREAS the Assignor is in liquidation and by the Notice of Appointment of Joint Liquidators dated 6<sup>th</sup> June 2014, Yuen Tsz Chun, Frank of KLC Kennic Lui & Co. of 5/F Ho Lee Commercial Building, 38-44 D'Aguilar Street, Central, Hong Kong, and Stuart Mackellar of Zolfo Cooper (BVI) Limited, PO Box 4571, 2<sup>nd</sup> Floor Palm Grove House, Wickhams Cay, Road Town, Tortola, British Virgin Islands were appointed as joint liquidators of the Assignor since 6<sup>th</sup> June 2014 (hereinafter collectively referred to as "the Liquidators").

AND WHEREAS the Assignor has agreed for the consideration hereinafter appearing to sell, assign and transfer unto the Assignee the Trademarks together with the whole of the goodwill of the business in the goods/services with respect of which the Trademarks are registered.

NOW THIS DEED OF ASSIGNMENT WITNESSETH as follows: -

In consideration of the payment of the sum of HK\$100,000 (Hong Kong Dollars One Hundred Thousand) (hereinafter referred to as "Consideration") by the Assignee to the Assignor and the promises and agreements herein contained, the Assignor and the Assignee hereby agree that:


- (1) The Assignor as beneficial owner HEREBY SELLS, ASSIGNS, TRANSFERS AND DELIVERS ABSOLUTELY unto the Assignee ALL THOSE of the Trademarks and all legal and beneficial rights, title and interest in and to the Trademarks including all statutory and common law rights attaching thereto, together with the whole of the goodwill attaching to the Trademarks and the goodwill of the business relating to the goods for which the Trademarks are used or are registered, TO HOLD USE EXERCISE AND ENJOY the Trademarks unto the Assignee its successors and assigns absolutely.

- (2) The Consideration shall be paid to the Assignor by the Assignee immediately upon the signing of this Deed of Assignment.
- (3) After the payment of the Consideration and upon the request of the Assignee, the Assignor shall execute and deliver to the Assignee only documentations required by the trademark registries, intellectual properties offices or any relevant authorities to perfect the transfer of the Trademarks in the trademark registries and intellectual properties offices or any relevant authorities upon receiving those documentations from the Assignee. The Assignee shall be responsible for preparing all documentations required to perfect the transfer of the Trademarks registrations and sending those documentations to the Assignor for the execution in any event within 2 months from the date of the payment of the Consideration. If the Assignee fails to furnish those documentations to the Assignor for the execution within the prescribed time, the Assignor is entitled to refuse to execute those documents. The Assignee shall pay all costs, expenses, registration and filing fees, stamp duties and all other charges, if any, arising from or incurring in connection therewith entirely and absolutely.
- (4) Notwithstanding anything in this Deed of Assignment to the contrary (i) the Trademarks assigned under this Deed of Assignment are assigned and assumed on an "as is" basis with no representations or warranties or undertakings made by the Assignor or the Liquidators, and the Assignor hereby excludes and disclaims any representations or warranties or undertakings of any kind with respect to the Trademarks, including non-infringement and any warranties implied by any course of dealing or trade usage unless they are expressly stated in this Deed of Assignment; and (ii) the Assignor in any event shall not be liable under any legal or equitable obligations for any direct, indirect, special, incidental, consequential, punitive or exemplary damages of any kind in connection with this Deed of Assignment notwithstanding that the Assignee has been advised by the Assignor of the possibility of such risks or damage prior to the date of this Deed of Assignment.
- (5) The Assignee further irrevocably acknowledges and agrees that no warranty has been or will be given by the Liquidators in relation to the accuracy and completeness of the information relating to the Trademarks. No representations, warranties or undertakings of any kind with respect to the Trademarks have been or will be given by the Liquidators on behalf of the Assignor.
- (6) The Assignee hereby irrevocably acknowledges and agrees that no personal liability of whatsoever will be incurred by the Liquidators in entering into or performing this Deed of Assignment on behalf of the Assignor.
- (7) No amendment, change or modifications of this Assignment shall be valid unless in writing and signed by all parties hereto.

- (8) This Deed of Assignment shall be binding on and shall inure to the benefit of the parties to this Deed of Assignment and their successors and assigns, if any.
- (9) Save as the Liquidators, nothing contained herein is intended to grant to any third party any rights to enforce any term hereof or to confer on any third party any rights or benefit hereunder for the purposes of the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the laws of Hong Kong) and any enactment thereof and the application of the said Ordinance is expressly excluded.
- (10) This Deed of Assignment shall be executed in duplicate.
- (11) Except where the context otherwise requires, words denoting the singular include the plural and vice versa; words denoting any one gender include every gender; words denoting persons include firms and corporations and vice versa.
- (12) This Deed of Assignment and the rights and obligations of the parties shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region of the People's Republic of China and the courts of the Hong Kong Special Administrative Region shall have non-exclusive jurisdictions over any disputes arising out of this Deed of Assignment.
