## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of December 16, 2021, is made by JPMorgan Chase Bank, N.A., on behalf of the Secured Parties (in such capacity, the “Lender”), in favor of Brightway Insurance, LLC (f/k/a Brightway Insurance, Inc.) (the “Grantor”). Capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreement (as those terms are defined below).

WHEREAS, the Grantor and the Lender are parties to that certain Pledge and Security Agreement, dated as of October 31, 2018 (as amended, supplemented or otherwise modified, renewed or replaced from time to time, the “Security Agreement”), in favor of the Lender, on behalf of Lender and the other Secured Parties;

WHEREAS, the Grantor and the Lender are parties to that certain Trademark Security Agreement, dated as of October 31, 2018, recorded with the United States Patent and Trademark Office on November 6, 2018 at Reel/Frame No. 6534/0639 (the “Trademark Security Agreement”);

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor pledged to the Lender, for the benefit of the Secured Parties, a security interest (referred to in this Release as the “Trademark Security Agreement”) in the Grantor’s right, title and interest in, to and under the Grantor’s Trademark Collateral (as defined in the Trademark Security Agreement), including the Trademarks referred to on Schedule 1 hereto (the “Released Trademarks”); and

WHEREAS, the Lender has agreed to terminate and release all of its right, title and interest in or to the Trademark Collateral, including the security interest therein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Lien. The Lender hereby terminates, extinguishes, cancels, releases and discharges any and all right, title and interest, including the security interest, in and to the Trademark Collateral arising in connection with the Security Agreement and assigns, discharges, quit claims and relinquishes unto each Grantor, as applicable, any and all right, title and interest it has in and to the Trademark Collateral, including:

- A. all Trademarks, including the Released Trademarks;
- B. all goodwill associated with or symbolized by the Trademarks;
- C. all assets, rights and interests that uniquely reflect or embody the Trademarks;
- D. the right to sue third parties for past, present and future infringements, dilutions or violations of any Trademark; and
- E. all proceeds of and rights associated with the foregoing.

2. Further Assurances. The Lender shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, such cooperation and assistance (including, without limitation, the execution and delivery of any documents or other instruments), reasonably requested by the Grantor, and at the Grantor’s cost and expense, to more fully and effectively effectuate the release of liens contemplated hereby.

3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York without regard to principles of conflicts of laws requiring application of the law of any other jurisdiction.
