2. Article I of the Amended and Restated Articles of Incorporation of this Corporation is amended to read in full as follows:

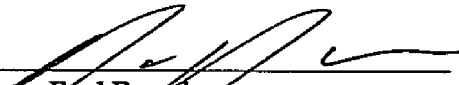
“The name of the corporation is Bitcentral, Inc.”
