TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS AND PATENTS** (this "Termination and Release") dated as of December 14, 2021, made by CANADIAN IMPERIAL BANK OF COMMERCE (the "Lender"), is in favor of FROST FIGHTER INC. (the "Obligor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Obligor executed an Intellectual Property Security Agreement dated October 1, 2014 (the "IP Security Agreement"), in favor of the Lender, granting the Lender security interests in and liens on certain trademarks and patents described therein (the "Trademark Collateral");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on October 9, 2014 at Reel 5378, Frame 0790 with respect to the Trademark Collateral and on October 9, 2014 at Reel 033925, Frame 0425 with respect to the Patent Collateral; and

WHEREAS, the Lender now desires to terminate the IP Security Agreement and terminate, release and discharge its security interest in all Trademark Collateral and Patent Collateral including the United States registered trademarks and patents set forth in Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby:

1. terminates the IP Security Agreement and absolutely, unconditionally and irrevocably terminates, releases, cancels and discharges all pledges, grants, liens and security interests in the Obligor's right, title and interest in, to and under the Trademark Collateral and the Patent Collateral under the IP Security Agreement, including the Trademark Collateral and Patent Collateral identified in Schedule A hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. understands and agrees that this Termination and Release may be recorded by or for the Obligor or its successors or assigns with the USPTO.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE PROVINCE OF BRITISH COLUMBIA AND THE LAWS OF CANADA APPLICABLE THEREIN, EXCLUDING CONFLICT OF LAW RULES OF THAT PROVINCE.
