**TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

**THIS TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS** (this "*Termination*"), is dated as of December 23, 2021, and made by **U.S. BANK NATIONAL ASSOCIATION**, as administrative agent (the "*Grantee*"), in favor of **COASTAL FARM & HOME SUPPLY LLC**, an Oregon limited liability company (the "*Grantor*").

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of October 30, 2020, by and among the Grantee, the Grantor and certain other parties thereto (as amended, restated or otherwise modified from time to time through the date hereof, the "*Loan Agreement*"), a security interest was granted by the Grantor to the Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, pursuant to the Loan Agreement, the Grantor executed and delivered to the Grantee that certain Notice of Grant of Security Interest in Trademark Rights, dated as of October 30, 2020 (as amended, restated or otherwise modified through the date hereof, the "*Security Agreement*"), for recordal with the United States Patent and Trademark Office;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on November 5, 2020 at Reel 7096, Frame 0784; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on **Schedule A** hereto and the associated goodwill.

2. Release of Security Interest. Grantee does hereby terminate, release and discharge the entirety of any and all liens or security interests that it may have in, and all claims, whether presently existing or hereafter acquired or created, pursuant to the Security Agreement in the Trademarks and re-transfers, re-conveys and re-assigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.

3. Termination. The Grantee, without representation or warranty of any kind, terminates and cancels the Security Agreement.

4. Further Assurances. The Grantee agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor at Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Termination.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of Oregon.
