ASSIGNMENT OF INTELLECTUAL PROPERTY

WHEREAS, Assignor is the owner of all the rights, interests and claims in, and title to the trademarks, domain name, and other intellectual property set forth in **EXHIBIT A** together with the common law rights and goodwill associated therewith (the "Intellectual Property") together with the social media accounts and usernames associated with or operated by Assignor set forth in **EXHIBIT B** (the "Accounts").

WHEREAS, Assignor was acquired by Assignee on or around March 1, 2021.

WHEREAS, Assignor wishes to assign, by virtue of this Assignment Agreement, all worldwide rights, interests, and claims in, and title to the Intellectual Property and the Accounts, together with the common law rights and goodwill associated therewith, to Assignee.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, Assignor hereby contributes, conveys, grants, sets over, assigns, and transfers to Assignee and its successors and assigns, and Assignee hereby accepts, Assignor's entire worldwide right, interest and claim in, and title to the Intellectual Property and the Accounts, together with the common law rights and goodwill associated therewith, as listed in the attached **EXHIBIT A**, together with the right to sue for and collect upon all claims for profits and damages as a result of past infringement of the Intellectual Property, if any, in each case whether now existing or hereafter created, together with the proceeds thereof.

Assignor hereby constitutes and appoints Assignee as Assignor's true and lawful attorney in fact, with full power of substitution in Assignor's name and stead, to take any and all steps, including proceedings at law, in equity or otherwise, to execute, acknowledge and deliver any and all instruments and assurances necessary or expedient in order to vest or perfect the aforesaid rights and related causes of action more effectively in Assignee or to protect the same or to enforce any claim or right of any kind with respect thereto.

Assignor shall at the reasonable request and the expense of Assignee: (a) execute and deliver or cause to be delivered any documents and further instruments of assignment consistent with the present assignment and that may be reasonably required to evidence or effectuate the assignment of the Intellectual Property, and (b) take or cause to be taken all such other actions, as may reasonably be deemed necessary or desirable in order for Assignee to obtain the full benefits of the present assignment of the Intellectual Property and to maintain and enforce the Intellectual Property in all countries.

Each party represents that it has the power and authority to enter into this Assignment Agreement. If any term of this Assignment Agreement is held void, voidable, invalid, inoperative or unenforceable for any reason, the remainder of such term shall be amended to

achieve as closely as possible the effect of the original term, and all other terms shall continue in full force and effect.

The terms and covenants of this Assignment Agreement shall inure to the benefit of Assignee, its successors and assigns, and shall be binding upon Assignor and its assigns.
