TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of December 31, 2021, by Antares Capital LP (“Antares Capital”) as administrative agent and collateral agent (in such capacities and together with its successors and assigns, the “Administrative Agent”) for the Secured Parties (as defined in the Credit Agreement, dated as of December 20, 2016, by and among, inter alios, Blue Star Intermediate, Inc., a Delaware corporation, Ansira Holdings, Inc., a Delaware corporation, the Administrative Agent and the lenders from time to time party thereto). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Brand Protection Agency, LLC, a Texas limited liability company (“Grantor”) and the Administrative Agent and certain other Grantors are parties to (i) that certain Pledge and Security Agreement, dated as of December 20, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and (ii) that certain Intellectual Property Security Agreement Supplement dated as of March 12, 2020 (the “IP Security Agreement”) pursuant to which the Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in the Trademark Collateral (as defined below);

WHEREAS, the IP Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 12, 2020, at Reel 6890, Frame 0484;

WHEREAS, Grantor has requested that the Administrative Agent, for itself and on behalf of the Secured Parties, release its security interest in the Trademark Collateral and reassign any and all rights in the same to Grantor;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Administrative Agent, on behalf of itself and the Secured Parties, hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “Trademark Collateral”):

- (i) each Trademark registration and registration application in the United States Patent and Trademark Office listed on Schedule I hereto; and
- (ii) all proceeds of the foregoing.

2. The Administrative Agent hereby reassigns, grants and conveys to the Grantor, without any representation, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent’s right, title and interest in and to the Trademark Collateral.

3. The Grantor, or any successor to the Grantor (including any person or entity hereafter having any right, title or interest in and to the Trademark Collateral) is hereby authorized to record this Release in the United States Patent and Trademark Office.
