**RELEASE OF PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES**  
**SECURITY AGREEMENT (TRADEMARKS)**

This **RELEASE OF PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES SECURITY AGREEMENT (TRADEMARKS)** (this “Release”) is effective as of January 10, 2022, by BANK OF AMERICA, N.A., a national banking association (successor to Fleet Capital Corporation), in its capacity as administrative agent (in such capacity, together with its successors and assigns, the “Agent”), in favor of Pro’s Choice Beauty Care, Inc., a New Jersey corporation, as grantor (the “Grantor”).

**WHEREAS**, pursuant to that certain Loan and Security Agreement, dated as of the 9<sup>th</sup> day of October, 2001 (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the “Agreement”) by and among, inter alios, the Grantor, the Agent, the financial institutions party thereto from time to time as lenders.

**WHEREAS**, pursuant to the Agreement, the Grantor and Agent entered that certain **PATENTS, TRADEMARKS, COPYRIGHTS AND LICENSES SECURITY AGREEMENT (Trademarks)**, dated as of the 9<sup>th</sup> day of October, 2001, by and between, the Grantor and the Agent, in which the Grantor granted to the Agent a security interest in and continuing lien upon the trademarks listed on Schedule 1 attached hereto (the “Trademarks”) and recorded with the United States Patent and Trademark Office on October 26, 2001 at Reel/Frame 2389/0858.

**NOW, THEREFORE**, intending to be legally bound hereby, the Agent hereby releases and terminates the Agent’s security interest in, and all other rights, title and interest in and to, the Trademarks, without any recourse, representation or warranty, and hereby authorizes the Grantor or Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
