## TRADEMARK ASSIGNMENT

This ASSIGNMENT is entered into by and between Dealer Services Network, Inc., a Florida corporation having an address of 3155 SW 10th Street Suite D, Deerfield Beach, FL 33442 (hereinafter "Assignor") and Dealer Services Network, LLC, a Florida limited liability company having an address of 3155 SW 10th Street Suite D, Deerfield Beach, FL 33442 (hereinafter "Assignee") and made effective as of January 6, 2022, even though it may be executed before or after said date.

WHEREAS, Assignor, is the owner of all right, title and interest in and to U.S. Trademark Serial No.: 87/424,577 for **DEALER SERVICES NETWORK** in standard characters in connection with business support services, namely, business consulting to automobile dealerships regarding products and services for optimizing operations (now U.S. Registration No.: 5,563,537), U.S. Trademark Serial No.: 87/424,572 for **DOCUPRO** in standard characters in connection with records management services, namely, document indexing for others, physical storage of documents; physical storage of electronically-stored documents, and electronic storage of documents; Scanning, namely, digitization of documents (now U.S. Registration No.: 5,363,527), U.S. Trademark Serial No.: 87/424,595 for **TITLEPRO** in standard characters in connection with providing vehicle title and registration services for others which allows automobile dealerships to create an extension of their title department and utilize private tag agencies to more effectively service their customers (now U.S. Registration No.: 5,339,597), U.S. Trademark Serial No.: 87/424,579 for **DEALER SERVICES NETWORK** in a stylized design in connection with business support services, namely, business consulting to automobile dealerships regarding products and services for optimizing operations (now U.S.

Registration No.: 5,593,012), and U.S. Trademark Serial No.: 87/432,912 for **DEAL TRACKER** in standard characters in connection with providing a website featuring technology and providing temporary use of non-downloadable software applications that enable automobile dealership users to verify features of their physical deal jackets that are sent offsite for processing (now U.S. Registration No.: 5,477,398)(collectively, the "Marks"), together with all goodwill of the business symbolized by the Marks;

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Marks, and the goodwill of the business symbolized by the Marks;

NOW, THEREFORE, in consideration of the sum of One U.S. Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, Assignor by these presents does irrevocably sell, assign, and transfer to Assignee, all right, title and interest including, without limitation, any rights arising from contract law, trademark law, or otherwise, in and to: (a) the Marks, and all goodwill associated therewith; (b) any and all registrations of the Marks, whether state, federal or foreign; (c) any and all applications to register the Marks, whether state, federal or foreign; (d) all common law rights in, to and under the Marks or the literal element represented in the Marks owned by Assignor, and all goodwill associated therewith; (e) any and all other rights in, to and under the Marks including without limitation any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Marks and/or the goodwill of the business symbolized by the Marks; and (f) all claims or causes of action Assignor has or may have in connection with the Marks, including, but not limited to, the right to sue and recover damages for any and all past infringements of the Marks.
