**TERMINATION AND RELEASE OF NOTICE OF GRANT OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "*Termination*"), is dated as of January 12, 2022, and made by U.S. BANK NATIONAL ASSOCIATION (the "*Grantee*"), to POINT B, INC., a Washington corporation (the "*Grantor*").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademark Rights, dated as of February 15, 2019 (as amended, restated or otherwise modified through the date hereof, the "*Security Agreement*"), made by Grantor in favor of Grantee a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on February 19, 2019 at Reel 6566, Frame 0349; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks" as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks, including, listed on **Schedule A** hereto.

2. Release of Security Interest. Grantee does hereby (i) terminate the Security Agreement, (ii) terminate release, cancel and discharge the entirety of any and all liens or security interests that it may have in, and all claims acquired or created, pursuant to the Security Agreement in the Trademarks and (iii) reassign to the Grantor all right, title and interest of Grantee in the Trademarks. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.
