RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “**Release**”), dated as of January 26, 2022 (the “**Effective Date**”), is executed by CULTIVIAN SANDBOX FOOD & AGRICULTURE FUND III, LP, a Delaware limited partnership, as agent for the Lenders described below (in such capacity, the “**Agent**”) in favor of COOKS VENTURE, INC., a Delaware corporation (the “**Company**”), COOKS VENTURE POULTRY, INC., a Delaware corporation (“**CVP**”), and COOKS VENTURE POULTRY JAY, INC., a Delaware corporation (“**CVPJ**”) and, together with the Company and CVP, individually and collectively, jointly and severally, the “**Debtor**”), having its chief executive office at 695 Washington St., Apt. A., New York, NY 10014.

RECITALS

WHEREAS, the Debtor, the Agent and the Lenders party thereto and described therein (the “**Lenders**”) executed that certain Security Agreement, dated as of January 5, 2022 (the “**Security Agreement**”), pursuant to which, among other things, the Debtor granted to the Agent for the benefit of the Lenders a security interest in the Debtor’s intellectual property and certain other Collateral described therein (capitalized terms used but not otherwise defined herein shall have the meanings given to them in the Security Agreement);

WHEREAS, in furtherance of the foregoing, the Debtor executed that certain Trademark Security Agreement, dated as of January 5, 2022, in favor of the Agent for the benefit of the Lenders, a copy of which was recorded in the United States Patent and Trademark Office on January 5, 2022 (the “**Trademark Security Agreement**”), pursuant to which the parties thereto caused to be reflected as of record the Debtor’s grant of a security interest in the registered trademarks, service marks (and applications and registrations therefor) of the United States identified on Schedule 1 attached hereto (collectively, the “**Trademarks**”); and

WHEREAS, pursuant to that certain payoff letter, dated on or about the date hereof, among the Debtor, the Agent and the other Lenders (the “**Payoff Letter**”), the Agent has agreed to release its security interests in and liens on the Trademarks in accordance with the terms and conditions thereof, and has agreed to execute this Release to evidence of record such release.

RELEASE

NOW, THEREFORE, the Agent agrees as follows, effective as of the Effective Date:

1. The Agent is executing and delivering this Release as evidence of the release of security interests in and liens on the Trademarks and the other Trademark Collateral (as defined in the Trademark Security Agreement) as contemplated by paragraph 1 of the Payoff Letter.

2. The Agent hereby expressly releases its security interest in and liens on the Trademarks and the other Trademark Collateral and hereby assigns to the Company any


right, title and interest whatsoever in and to the Trademarks and the other Trademark Collateral that the Agent may have.
