**Assignment and Assumption of  
Notice of Grant of Security Interest in Trademarks**

ASSIGNMENT AND ASSUMPTION OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Assignment and Assumption") effective as of January 14, 2022 ("Effective Date") is made by Credit Suisse AG, Cayman Islands Branch, as resigning collateral agent, as assignor ("Assignor"), and Wilmington Savings Fund Society, FSB, as collateral agent, as assignee ("Assignee").

**WHEREAS**, Isagenix Worldwide, Inc. ("Grantor") executed that certain Notice of Grant of Security Interests in Trademarks ("Trademark Security Notice"), pursuant to that certain Security Agreement dated as of June 14, 2018 among Grantor, the other "Pledgors" party thereto, and Assignor (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"), and that certain Credit Agreement, dated as of June 14, 2018 (as amended by that certain Amendment No. 1 to Credit Agreement, dated as of August 25, 2020, and as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), pursuant to which Assignor received from Grantor a security interest in certain trademarks set forth in the Trademark Security Notice, including, but not limited to, the trademarks set forth on Exhibit A ("Trademark Collateral"), which Trademark Security Notice was recorded at the United States Patent and Trademark Office ("USPTO") at Reel 6353, Frame 0507; and

**WHEREAS**, pursuant to that certain Successor Agent Agreement dated as of the date hereof by and among Assignor, as resigning administrative agent and collateral agent, and Assignee, as succeeding administrative agent and collateral agent, among other parties ("Instrument"), Assignor has irrevocably assigned to Assignee all of its rights, powers and duties as Administrative Agent and Collateral Agent under the Credit Agreement and other Loan Documents, including the Trademark Security Notice.

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of the parties hereto agree as follows:

1. Terms not otherwise defined herein shall have the meanings assigned to them under the Security Agreement and, to the extent not defined in the Security Agreement, the Credit Agreement.
2. Assignor hereby, pursuant to the terms of the Instrument, without warranty, representation or recourse of any kind, either express or implied, assigns and transfers to Assignee, and Assignee hereby accepts, all of Assignor's rights, title, interest, responsibilities and duties in and to the Trademark Security Notice.
3. The parties hereby authorize and request the USPTO to record this Assignment and Assumption with respect to the Trademark Collateral registered thereat.
4. This Assignment and Assumption has been entered into pursuant to and in conjunction with the Instrument, which is hereby incorporated by reference herein. The provisions

of the Instrument shall supersede and control over any conflicting or inconsistent provision herein.

5. This Assignment and Assumption shall be governed by and construed in accordance with the laws of the State of New York.
6. This Assignment and Assumption may be executed in multiple counterparts (including delivery by PDF), each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
