TRADEMARK ASSIGNMENT

Effective immediately, Assignor does hereby irrevocably assign to Assignee all of its rights, title, and interest (including, but not limited to, all registration rights with respect to the CRAZY A’S Trademark, all rights to prepare derivative trademarks, all goodwill of the business symbolized by the CRAZY A’S Trademark, including U.S. Registration No. 4714955 and all other rights in and to the CRAZY A’S Trademark.
2. Assignor represents that it has the right, power, and authority to enter into this Agreement and that the Trademark is free and clear of any liens, encumbrances, licenses, and security interest.
3. The Agreement is valid, binding, and enforceable according to its terms.

4. Assignor agrees to cause to perform all lawful acts to execute such further documents as Assignee may reasonably request to fully effectuate this Agreement, including the documents necessary for causing recordation with the United States Patent and Trademark Office.


5. Assignor authorizes Assignee to complete recordation, and the United States Patent and Trademark Office and any other government officials to record and register this Assignment.


